

# ANTI-RAGGING COMMITTEE (2023-24)

#### Preamble

Under the Maharashtra Prohibition of Ragging Act 1999, ragging within or outside the institute campus is strictly prohibited. Whomsoever directly or indirectly commits, participates in, abets or propagates ragging within or outside the institute campus shall on conviction, be punished with imprisonment for a term up to 2 years and or penalty which may extend to 10,000/- rupees. Any student convicted of an offence of ragging shall be dismissed from the institute and such student shall not be admitted in any other educational institution for a period of five years from the date of such dismissal.

#### **Objectives**

- To eliminate ragging in all its forms from universities and other higher educational institutions by prohibiting it under Maharashtra Prohibition of Ragging Act 1999, and punishing those who indulge in ragging as per the Regulations.
- To prevent any physical or mental torture or any disorderly conduct towards any student causing apprehension, dread, humiliation, or agitation in him or her.

#### **Functions**

- To avoid and prohibit ragging in campus.
- To ensure overall disciplined environment in the College.
- To initiate timely action against erring students.
- To sensitize students about the evils of ragging and its prevention in the college campus by organizing orientation programs, talks etc.

### Frequency of the Meeting

Anti-ragging committee conducts biannual meetings.
