#### **Preamble**

In the course of carrying out the duty or during the consumption of the services and the facilities of the institution, there may arise a need for any student, or a member of the teaching / non-teaching staff to seek the intervention of competent authority to listen to and address their valid grievance. As per the directives of the UGC, AICTE and the Savitribai Phule Pune University a grievance redressal committee with the recommended composition is instituted at the institute. The appointments in the committee are done for a period of one year. The director is head of the committee and an ombudsman appointed by the SPPU is part of the committed. Other members include the competent teaching and non-teaching staff as per the directives and also a student representative.

There is a defined time bound mechanism documented and implemented for the redressal of the grievance irrespective of the nature of grievance and the grieved person or persons. The grievance committee members are available and approachable to everyone without the any restrictions. An online grievance reporting is possible with a grievance link available on the institutional website. Student, parent, any employee of the institute can make the use of it. During the regular meetings of the committee collective decision is made regarding the course of action and every possible effort is made to address the grievance amicably. The record of all proceedings, decisions and result of the working of the committee is maintained.

### **Objectives**

- 1. To make sure that all statutory requirements are addressed and guidelines are followed.
- 2. To make the grievance mechanism simple, user friendly and available to all concerned.
- 3. To address every grievance in a time bound manner, and with due prudence.
- 4. To maintain the communication, record of grievance redressal workings.
